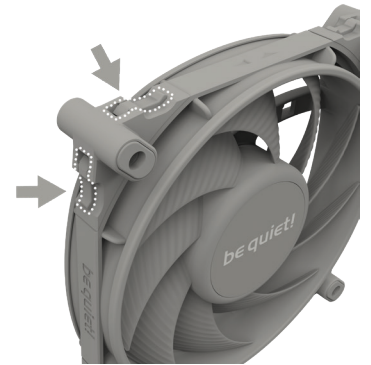
## Installation of the hard plastic fittings Installation der Hart-Kunststoff-Befestigungen

- EN** Clip the hard plastic elements from above onto the fitting lock.
- DE** Stecken Sie das Kunststoff-Element von oben auf den Steckverschluss.



- EN** To remove the hard plastic elements, press down the latching lugs on the right and left side to remove the hard plastic elements. Then pull the mounting element upwards.
- DE** Drücken Sie zum Entfernen der Hart-Kunststoff-Elemente die Einrast-Nasen auf der rechten und linken Seite runter. Ziehen Sie nun das Montage-Element nach oben weg.

- EN** Screw down the fan using the included screws.

## Installation of the anti-vibration fittings Installation der Anti-Vibrations-Befestigungen

**1** **EN** The rubber elements as well as the fitting locks are engraved on the inside.

- When positioned towards "L" there is 1 mm gap between the housing and the fan frame, resulting in the maximum possible decoupling.
- When you position the rubber elements towards "S" they fit flush with the housing.

**DE** Die Antivibrationselemente sowie die jeweiligen Steckverschlüsse sind innen beschriftet.

- In Richtung „L“ eingesetzt ist zwischen dem Gehäuse und Lüfterrahmen 1mm Luft. Dies hat eine maximal mögliche Entkopplung zur Folge.
- Setzt man die Gummi-Elemente in Richtung „S“ ein, schließen diese mit dem Gehäuse bündig ab.
